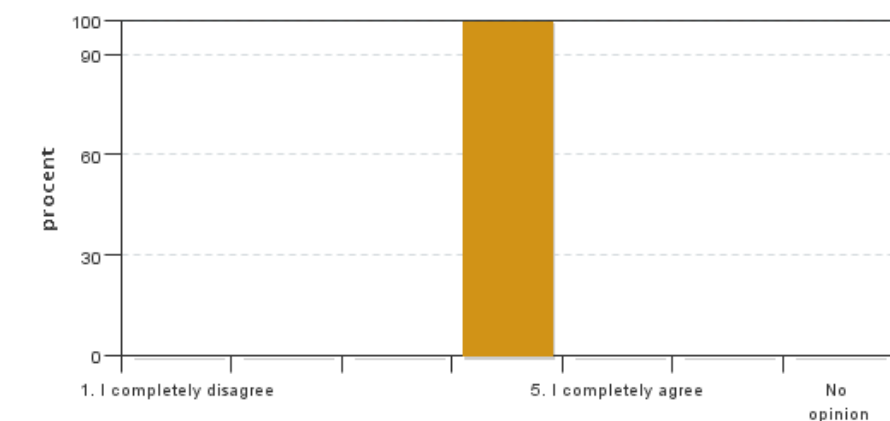

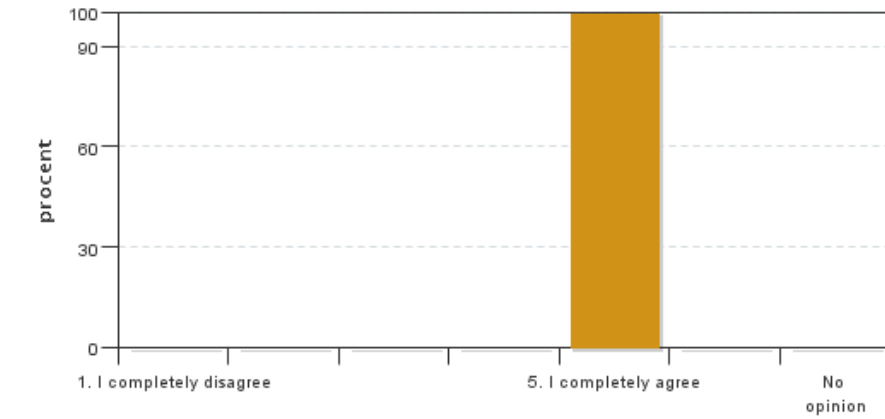

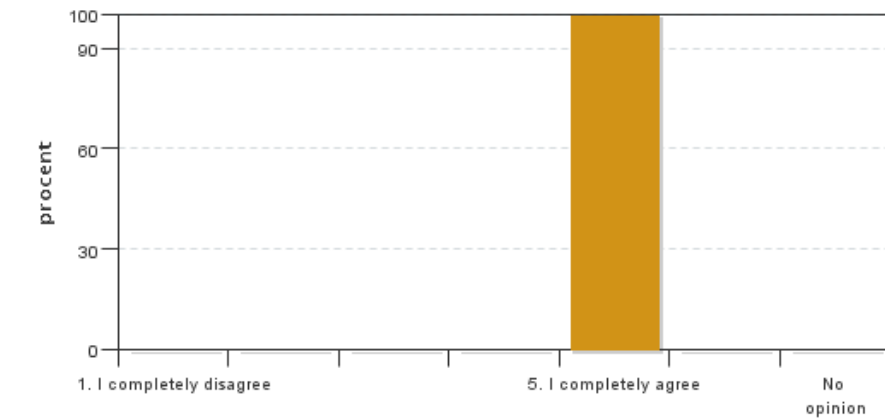

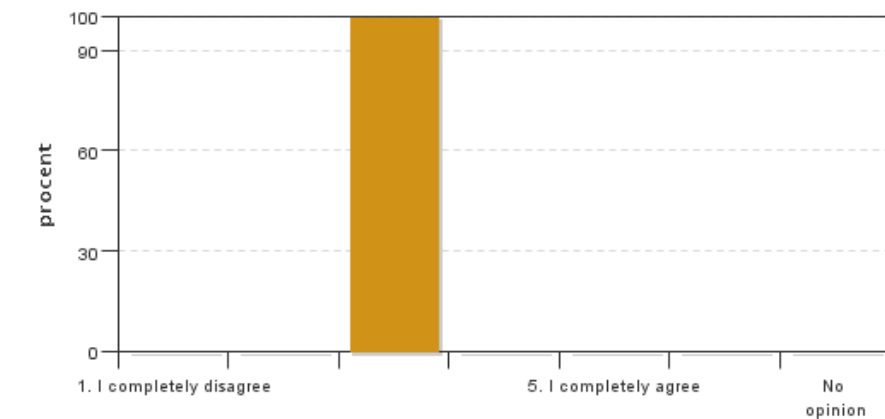

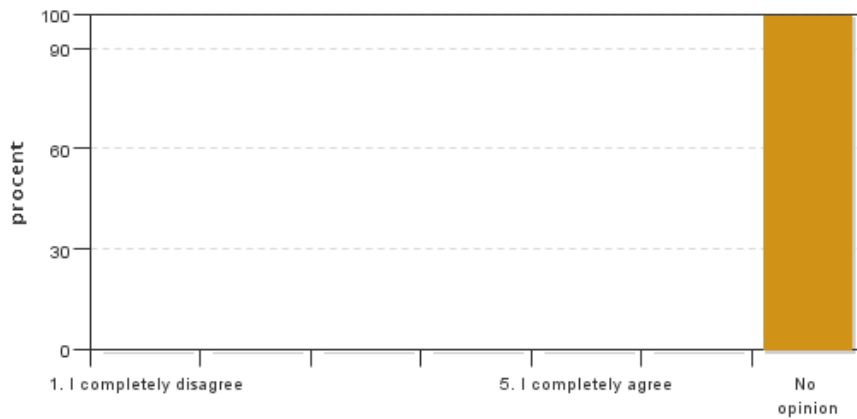

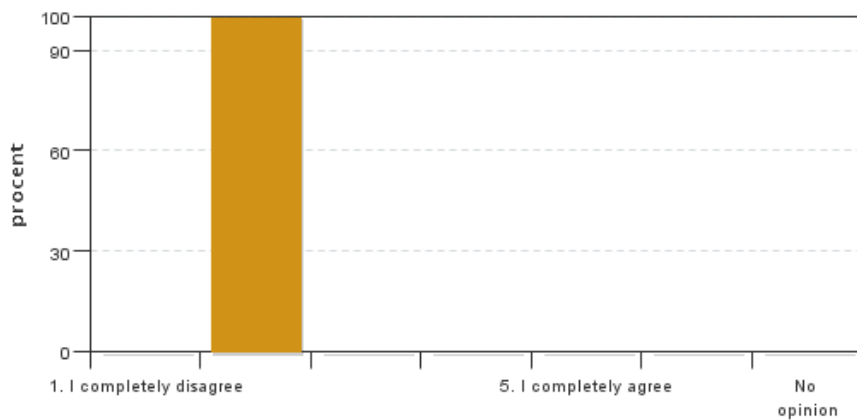

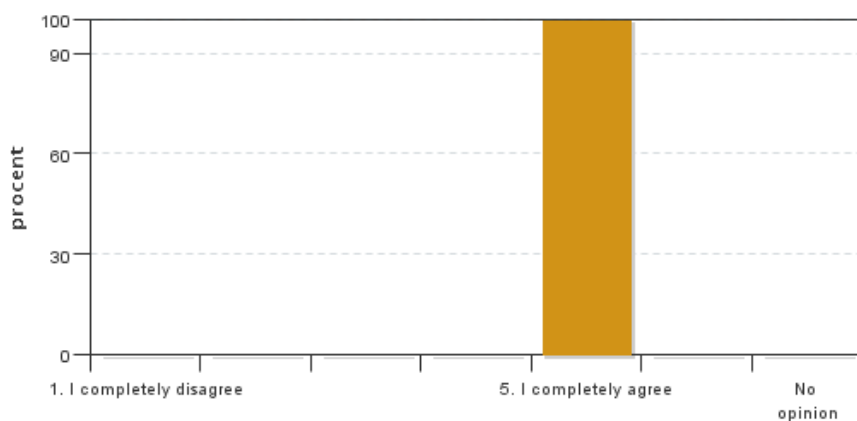

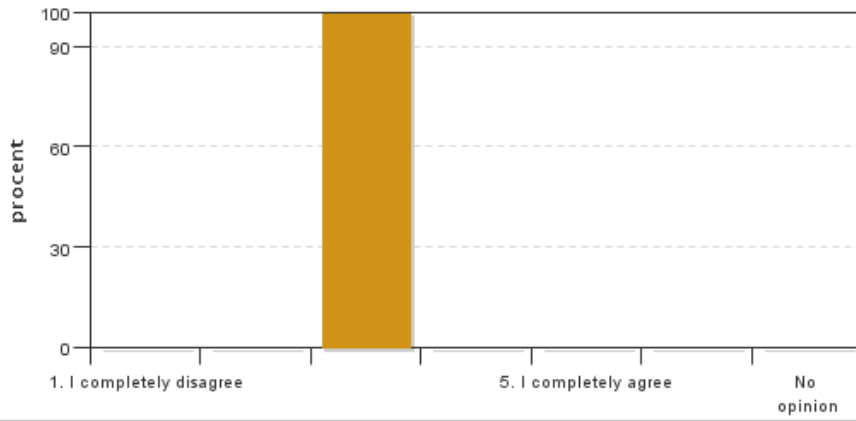

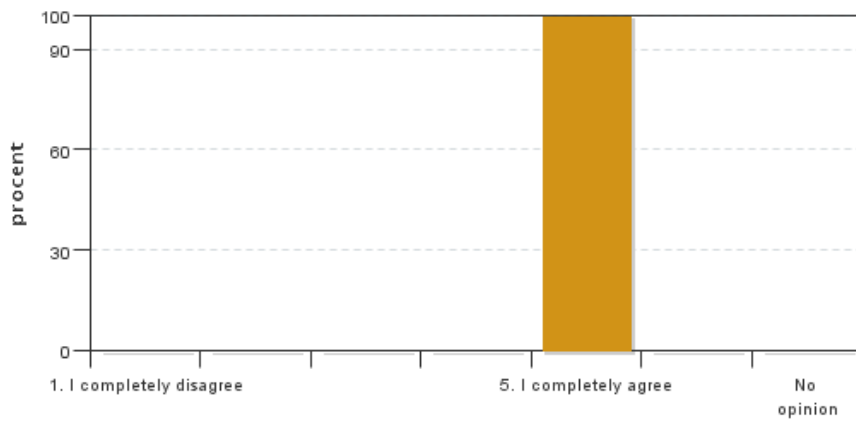

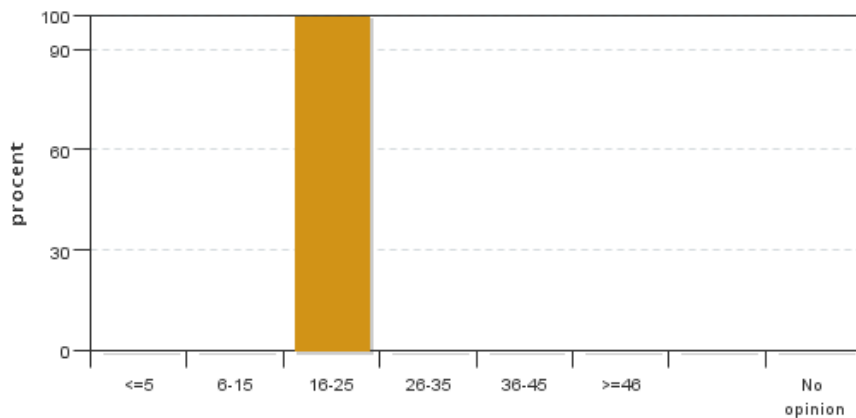

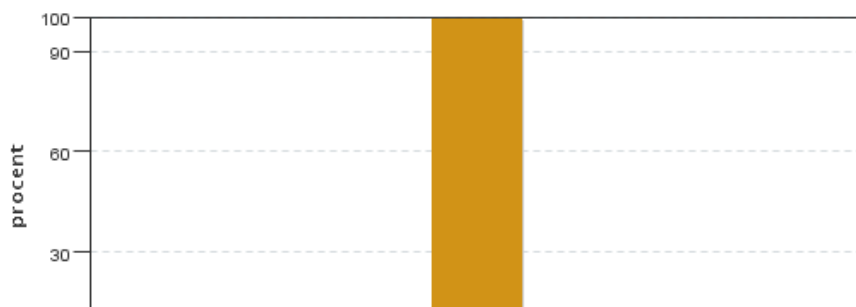

Course leaders comments

We completed a 100% online delivery of SG0248 for the first time. Although there is only one student providing feedback to the evaluation, we are pleased that this reflection parallels informal feedback we received during the course. For instance, students found breakout rooms to be efficient and there was adequate support to complete assignments.

As in previous years, we found a general appreciation for how sustainability issues were covered in the course. We did not identify issues related to the delivery of workshops related to use of various spreadsheets in linear-programing exercises. We see an opportunity to expand the inclusion of gender related issues in our teaching which we will reconsider in upcoming teachings.

This is our second year offering the course in Modules. It seems to work well for students and we continue to evaluate whether the entire teaching of the module on forest taxation and state appraisal should be delivered 100% in Swedish. Though we will continue to evaluate this depending on the composition of the incoming class in 2021.
