The timing of Easter and the fact this is a full-time course meant that I had to pack many lectures in at the beginning in order to give students the full picture before they chose their topic for the term paper. I will try to improve this next year.

It helps to represent the papers and come to know what other paper contained at the same time. The course teacher is very humble, gentle and student friendly. He appreciated all the learning process and tried to make the class interactive. To turn on the camera was a good option to make the class interactive but the best part he did not make it mandatory. He helped the students to make the proposal of term paper and give us very motivating feedback. Also, the examination was less stressful because of 9 hours home exam.

The schedule of the course was also great, it never overlapped with another ongoing course policy evaluation. In the starting of the course there was lots of theory and had a 10-day break and back-to-back 3 days seminar. If there is little break between theory class and seminar it will be better. Also, if teacher assistant takes the exercise class it will be clearer and will not pressure for the course teacher within the same class, theory class and exercise. Though course teacher motivates everyone to be respectful to other in the breakout room but sometimes some slight disrespectful attitudes of some classmates happened when discussions were held in breakout rooms. Such as ignoring comments or laughing in front of the camera when others were participating. Overall, the course was great.
