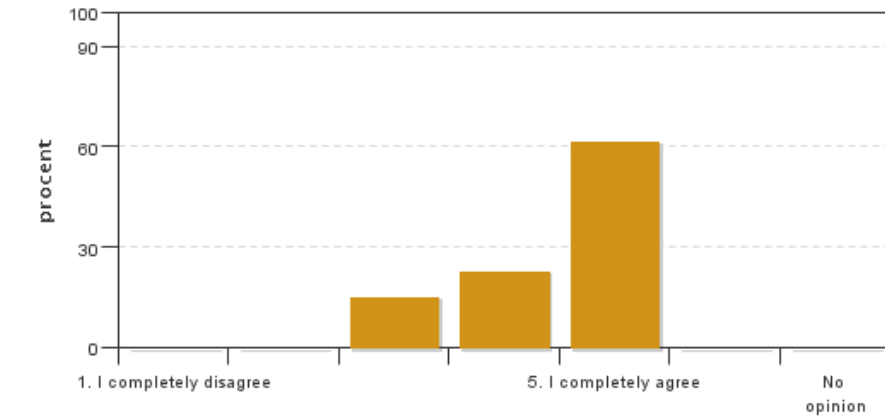

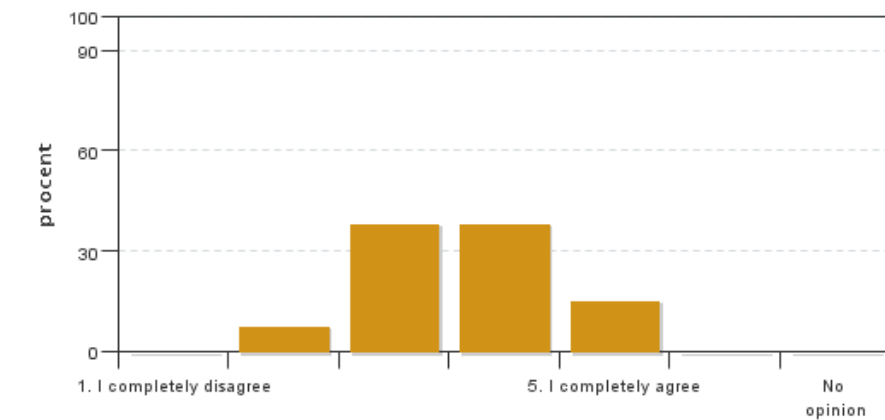

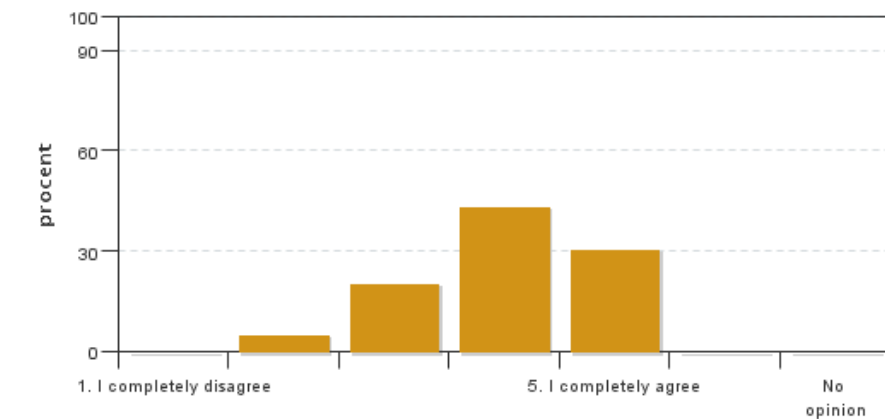

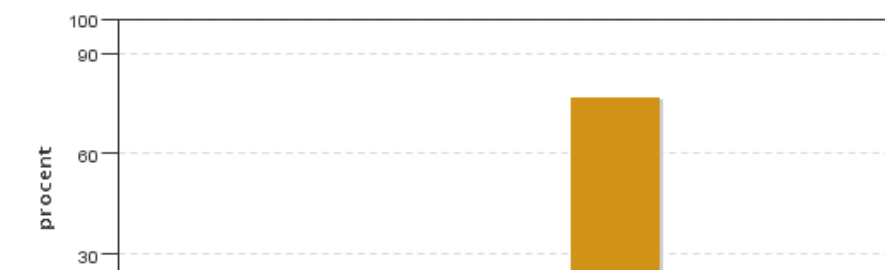

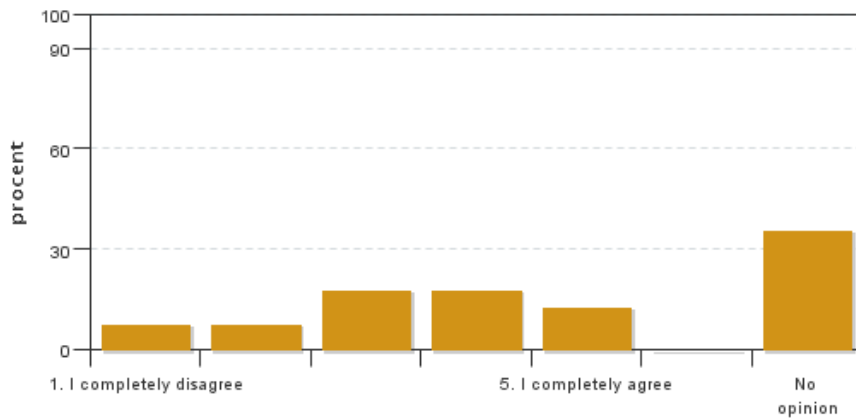

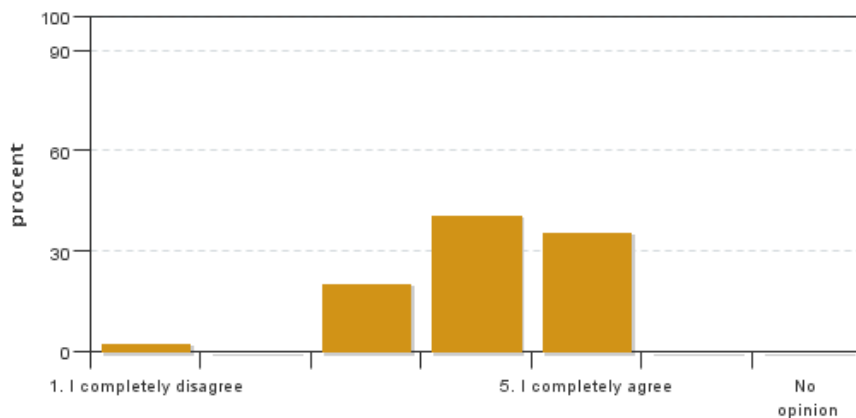

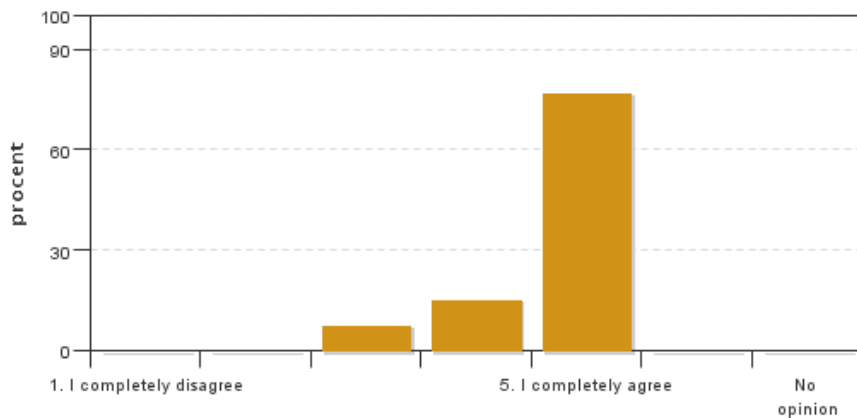

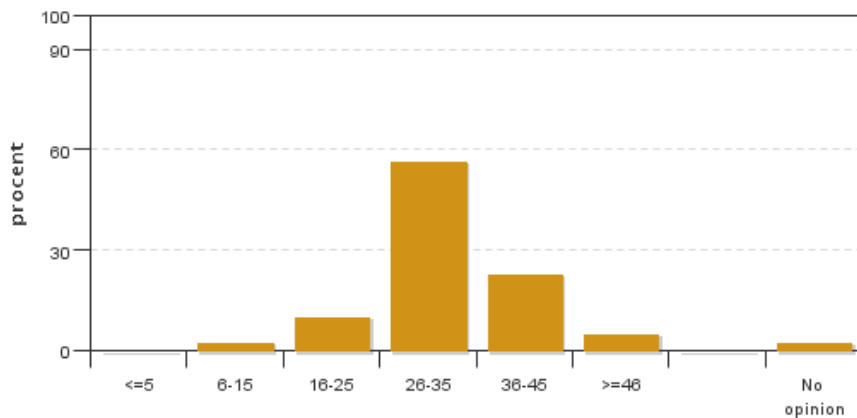

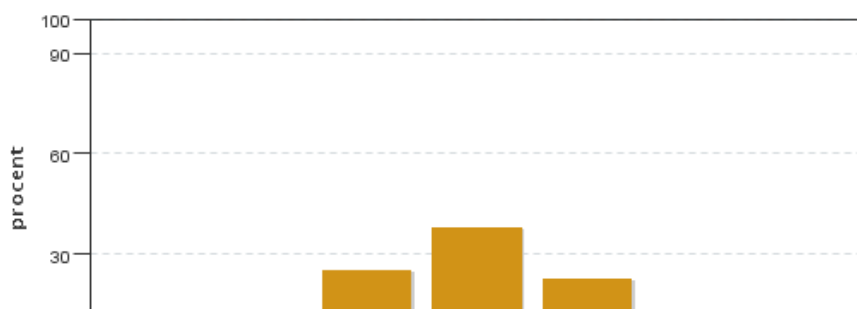

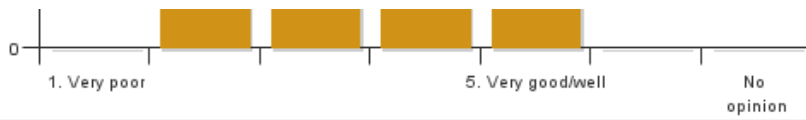

Student representatives comments

Overall the students had mixed reviews. Students benefited from learning about research tools which can be applied later for the thesis and were positive towards the course coordinator. Student's also responded positively to the course structure in relation to international, gender/equality and sustainable development perspectives. However, weaknesses were identified with the course requirement to have 8 person groups over zoom. Learning outcomes were identified as a weakness in relation to the heavy course load of the assignment that was a pass/fail compared to the exam outcomes that had complex questions with just 400-500 word maximums for a 15hp course. Another criticism was the accessibility to files, some of this was COVID and distance learning related however some of this could be improved by having a filing system within Canvas. Possible changes proposed by students include; varying presentation styles to improve engagement (if distance learning continues), improve the alignment between course outcomes and assessments, introduce a filing system and ensure all required reading is accessible.
