## Course leaders comments

This course occasion presented mainly the usual challenges connected to 1 . the broad thematic scope of the course covering a number of distinct topic 2 . diverse group of students with very different levels of prior knowledge. Teaching the economics concepts is still a challenge. One positive experience was using vignettes from YouTube explaining some of the concepts. The current home work with reporting in groups worked well, but more hands on exercises in class are needed.
It appears that the idea of students carrying out their own analysis using the computer based decision support system Heureka during the second week of the module needs to be given up. The students are not yet familiar enough with the program by then and seem not to be able to use the help documentation efficiently. Instead of the independent project, the first week's set of pre-defined calculations, which worked well, could to be extended. The general set of topics seems to rather have been appreciated, the comments did not allude week connections bewteen course elements as it happened in previous years.
