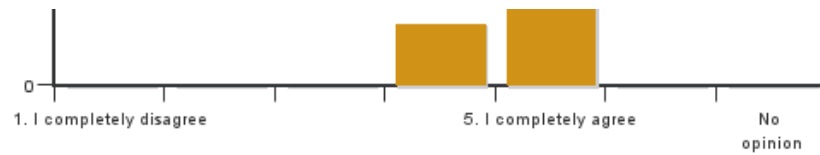

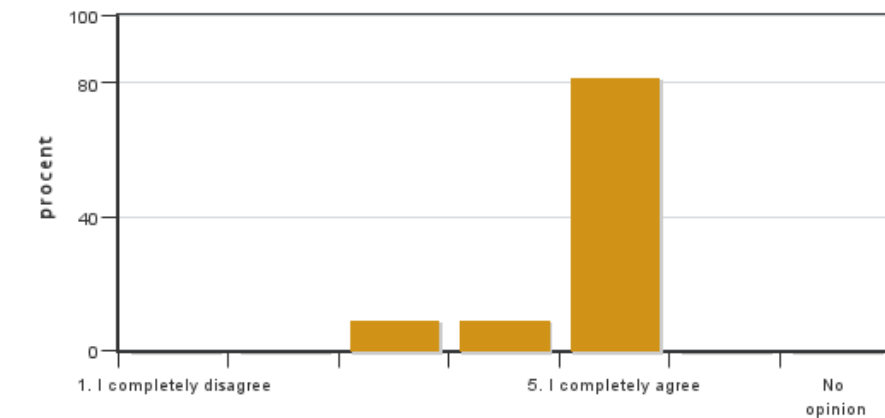

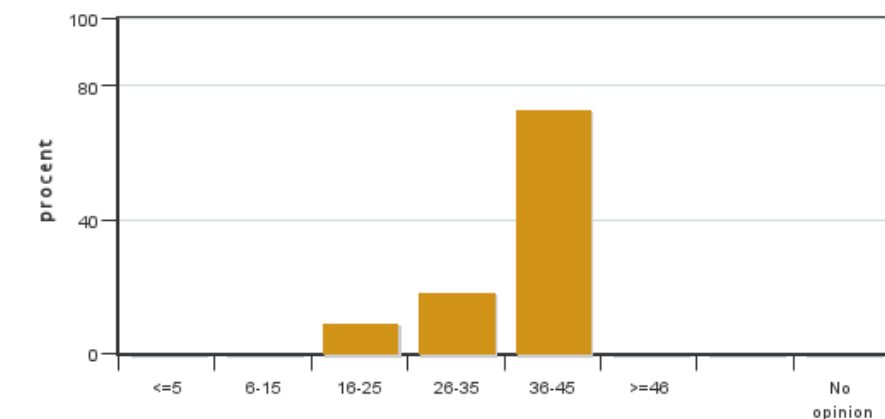

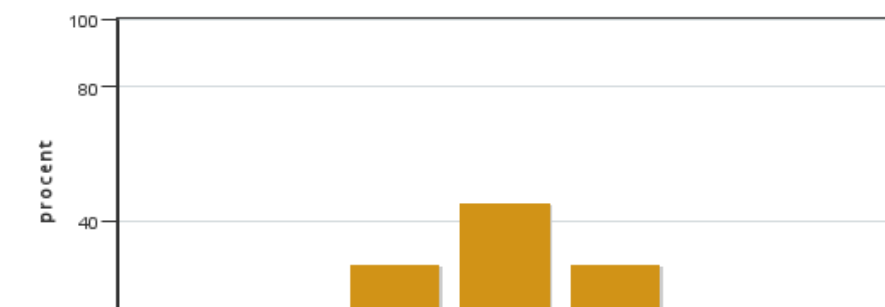

Student representatives comments

The overall impression from the students of this course has been very good. The course has had interesting topics that have felt very relevant to the field of study. As well as the course has involved a broad number of perspectives international/national and from working practitioners to researchers. This together with the course team has created a good learning environment for the students.

Parts of the course that have been particularly good

The second literature seminar when students had to think about examples of an EIA/SIA etc. from their own area was pointed out as a positive experience that gave good perspectives to the discussions. Reading and seeing different examples of these types of documents is important for understanding and should be encouraged early in the course.

The excursions were well planned with a good balance of stops that covered several different types of energy landscapes. The students felt it helped create an understanding of what energy landscapes look like. Perhaps more time could have been made to see the vattenriket in Kristianstad as this was not a mandatory stop. In general, the excursion was a positive experience and especially appreciated by the foreign students.

The student felt the course had a good number of teachers from different backgrounds and gave a comprehensive knowledge about the energy landscape but also the general landscape. The students felt that the lecture from länsstyrelsen was particularly good because it gave insight into how the planning processes for energy landscapes can take place.

Improvements to the course

In general, the students thought that the information about the course was clear. What could have been clearer is the links to the learning objectives of the course. Some students felt that there needed to be more clearance with what was expected of them, but they also felt that the tutoring opportunities were good and guided them to understand better. Perhaps more time to discuss the different assignments can be made between the course leader and the students.

To help future students a document explaining energy for dummies would be a good help to understand what energy is and can be. Students felt that this type of simple research took more time than necessary when doing different assignments early on. This document could perhaps include energy tangibility and how much energy is needed for different things.
