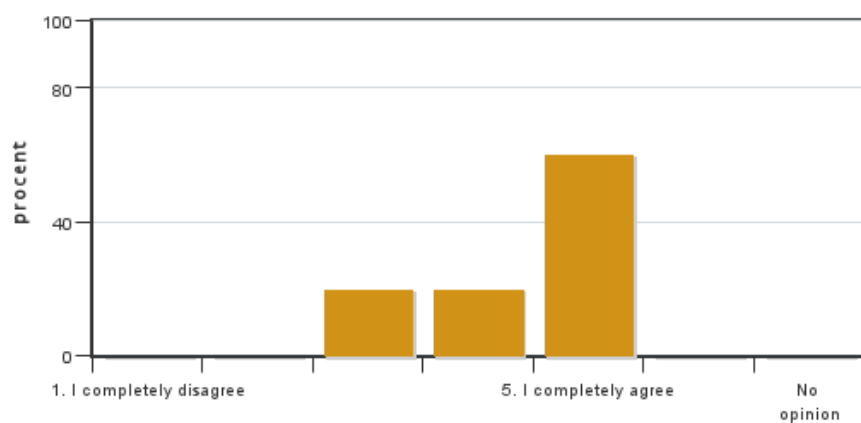

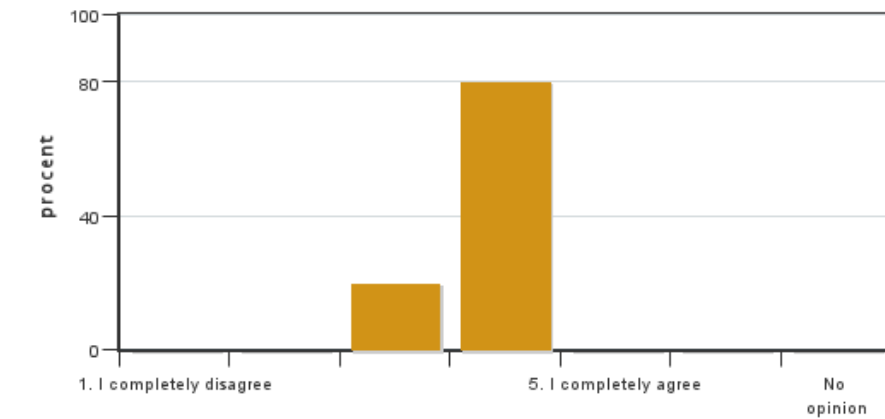

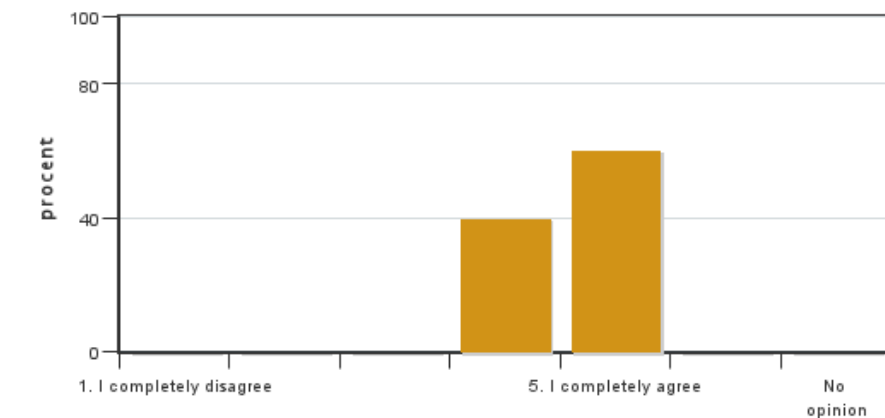

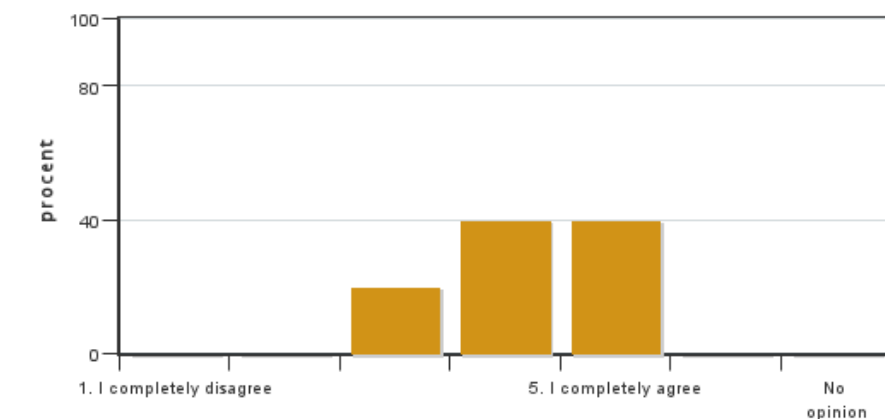

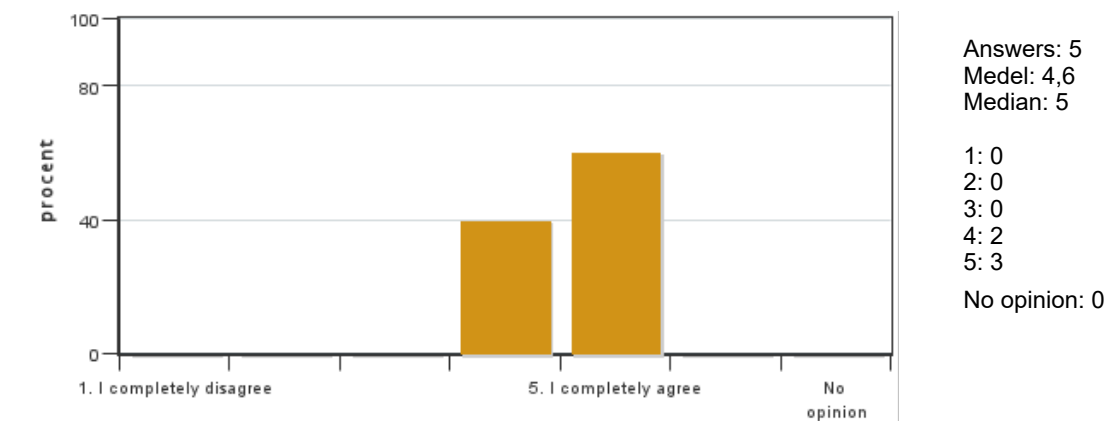

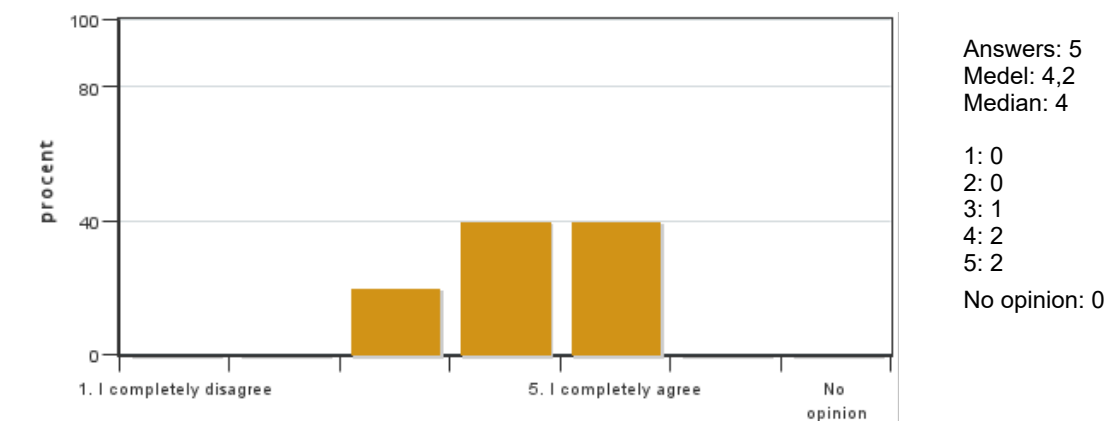

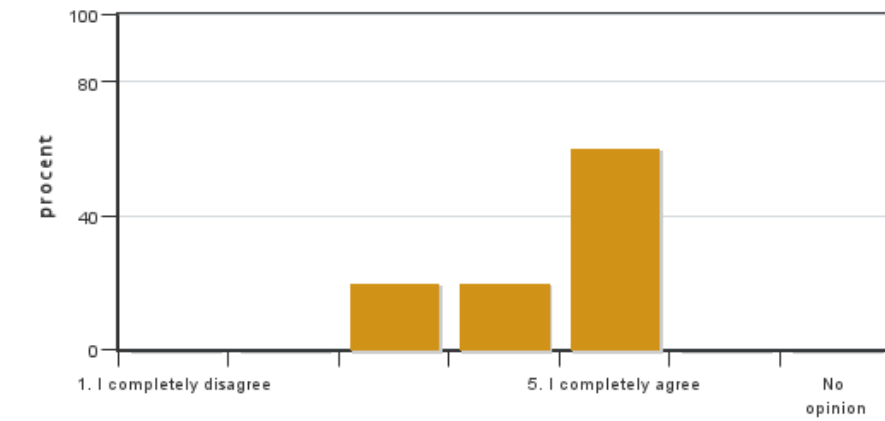

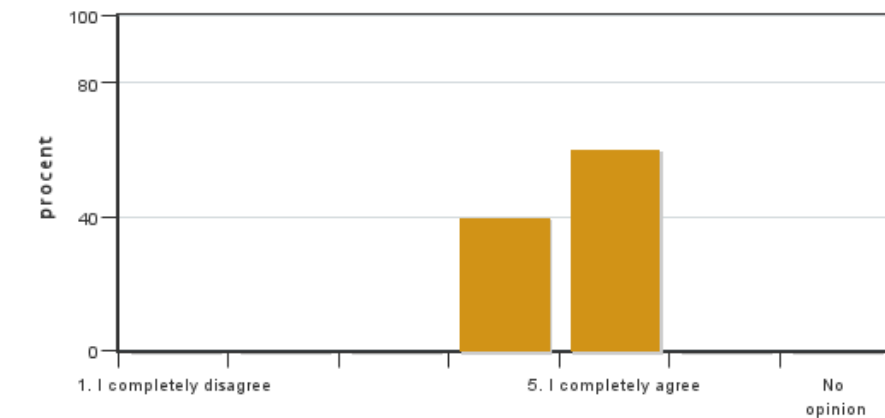

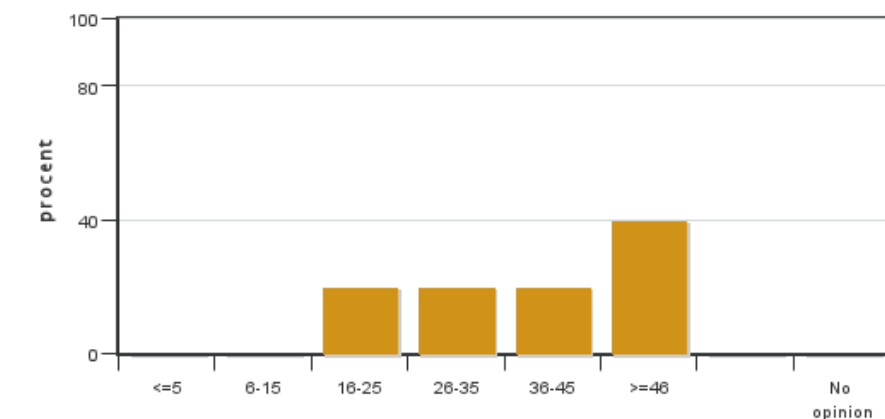

12. On average, I have spent ... hours/week on the course (including timetabled hours).

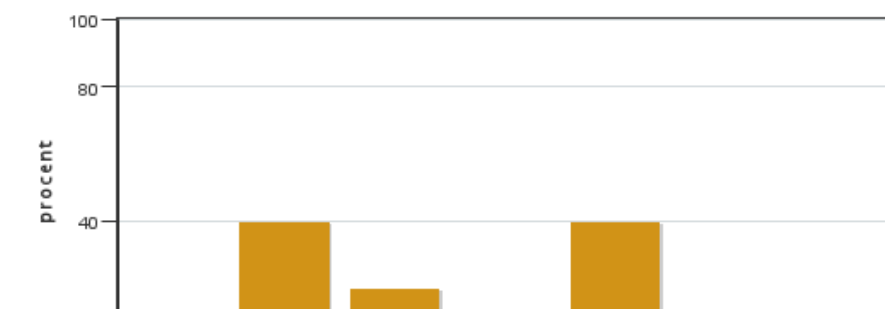

Course leaders comments

An extended course evaluation building on the learning experience questionnaire (Borglund et al., 2015) suggests that, overall, two out of three key aspects of the course received positive feedback, namely meaningfulness and comprehensibility. Students particularly appreciated working with up to date and interesting issues and literature, an open and inclusive atmosphere, being able to learn by trying out own ideas, receiving regular feedback and support and key concepts being given priority. The manageability aspect of the course would however need some revision to improve students' learning experience. We will consider how to improve two main issues here: offering more activities on campus and revising some parts of the course in a way that preserves the positive issues mentioned by the students. Overall, the students who participated in the course activities were very engaged and contributed to interesting discussions and term papers. Their high engagement is reflected not the least in several useful suggestions on how to further develop the course, which I would gladly take on board for the next year, e.g., revising the points of the term paper, learning objectives for each week, posting past exam earlier on, more preparation for the numerical exercises, and more instances of recalling what we went through so far.

Student representatives comments

The overall impression of the course was positive among the students. The students thought the social learning environment was inclusive and that different thoughts were respected. However, many students would have liked to have on-campus classes instead of pre-recorded lectures. At the same time, some students said they were thankful for having online and pre-recorded lectures since it enabled them to go back and listen to the lecture material once more. Many students also stated that they were satisfied with the hybrid solution for the seminars.

Regarding the course content, the students believed the content had a clear connection to the purpose of the course, emphasised international perspectives, and brought up a diversity of topics, but primarily linked to economic and environmental sustainability and that their previous knowledge was enough to pursue the course. Some students would, however, have liked to have a lecture/example/preparation before the farm bookkeeping and forest fair value assignments and more examples before the assignment in carbon accounting.

The course evaluation shows that the students were able to get support if they needed it and stated the teachers had been very encouraging and helpful during the course. The students also stated the assessment on the course had been fair and honest, but some exercises were experience tougher than others and should therefore have been given more credits. Many students were however happy with the point system and stated it made them keep on top of the content each week.

Regarding the workload, the students say some course contents have been challenging because of the volume of assignments. The students have in general studied 36,4 hours per week.

On the question of what advice, you would like to give to further participants, many students recommended other students to study and to try to look at the assignment first to prioritize articles to be read or lectures to watch.
