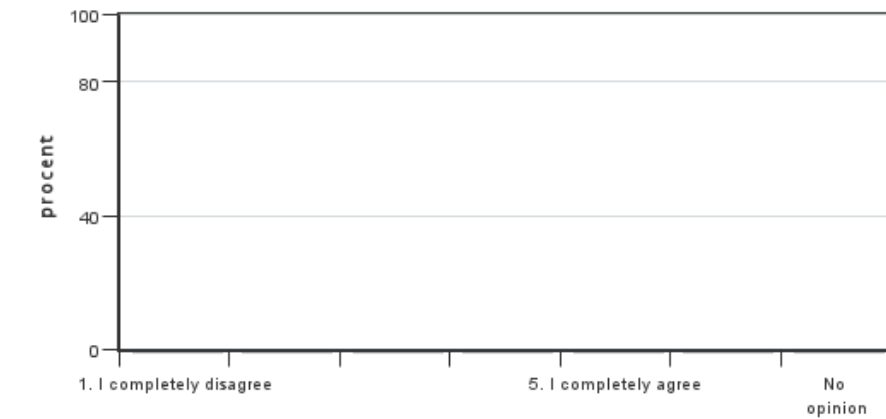

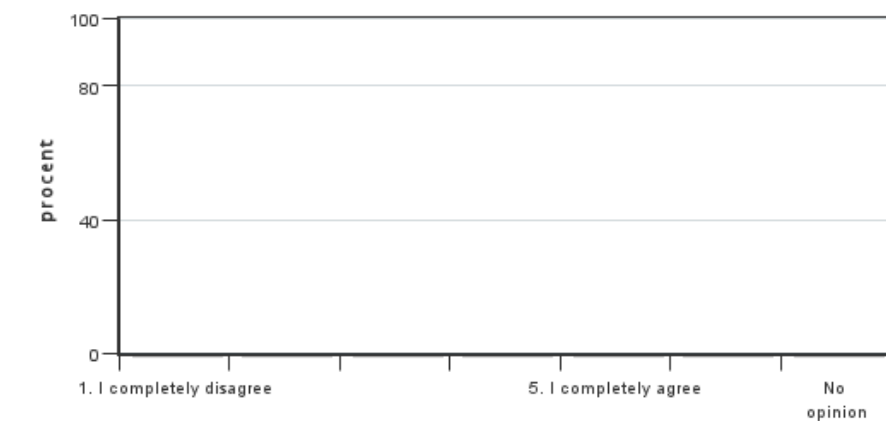

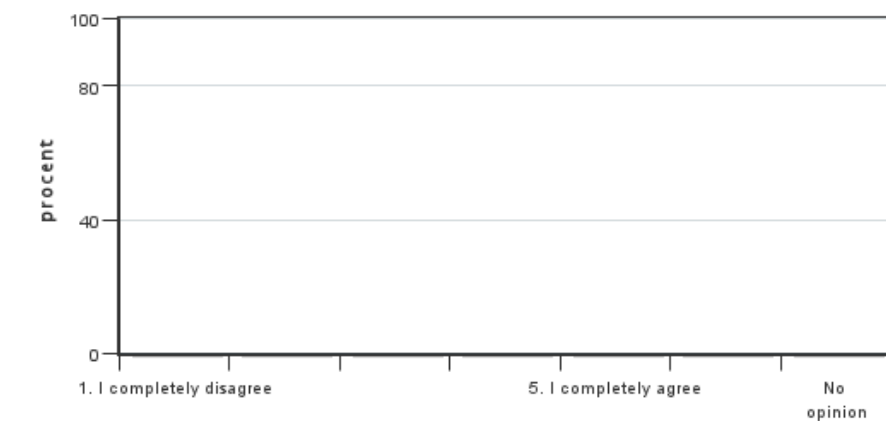

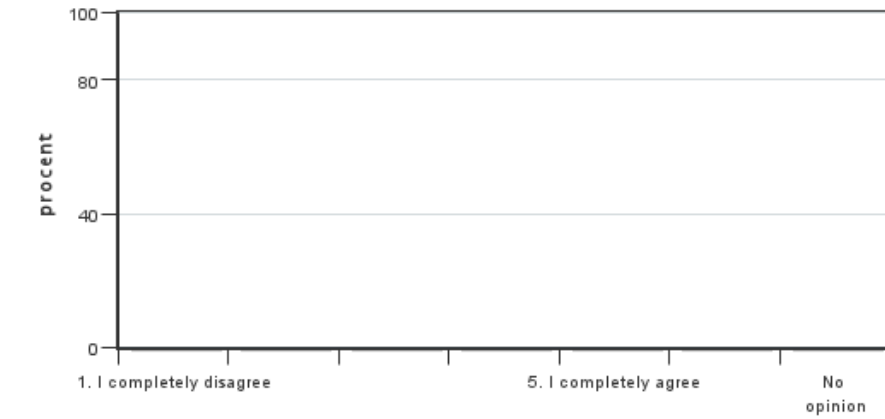

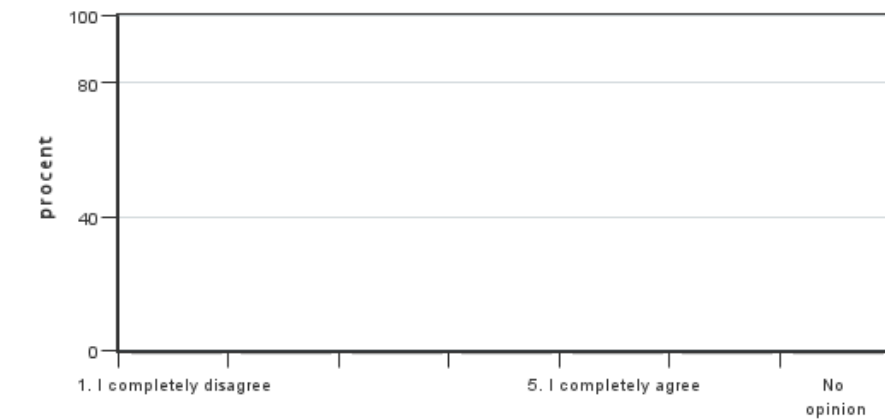

I am writing this paper to demonstrate my opinion and experience during the Master Thesis in Business Administration course at Swedish University of Agricultural Sciences. Currently, I am performing my second master's thesis with another university in Sweden, which gives me the chance to compare between the two experience and maybe better insights.

The SLU course was a great experience, it allowed me to learn many things in regards of how to think as a researcher. My thesis's supervisor was very generous with rich comments, and I believe that the supervisor's comments and feedbacks helped me a lot in a better understanding and thus results. The introductory course

lectures were beneficial, and the slides contents have many good insights regarding research structure and methods. I believe it was a very good recap of the Research Method for Business Studies course.

I have also got a message from another student in the course describing the course as a quiet smooth since there were not so many people in the course. The student felt it was super private and nice vibe to be in a small group. The student mentioned how the seminars feedback was helpful, especially the final seminar, and it was good to have enough time to implement the feedback into the thesis papers which I totally agree with.

In regards, to comparison between the two thesis courses with two different universities in Sweden, I believe that SLU course teaching strategy has more focus on delivering learning to the students and enhance self-study at the same time, while the other university provides three hours of supervision only (1st Idea Proposal, Midway Seminar, and after the final seminar), which I believe it is very limited for many students especially who have not done any thesis paper before the course. It could be the number of the students in the other university is high comparing to SLU group which considered as a limitation for providing more supervision hours. However, as a student experience I believe it was great that I have started SLU thesis before the other one, otherwise, I believe it would be a very hard experience. On the other hand, it is worthy to note again that the supervisor for thesis course is a focal point for each student's learning experience, and I believe my supervisor was a great teacher and helped me a lot.
