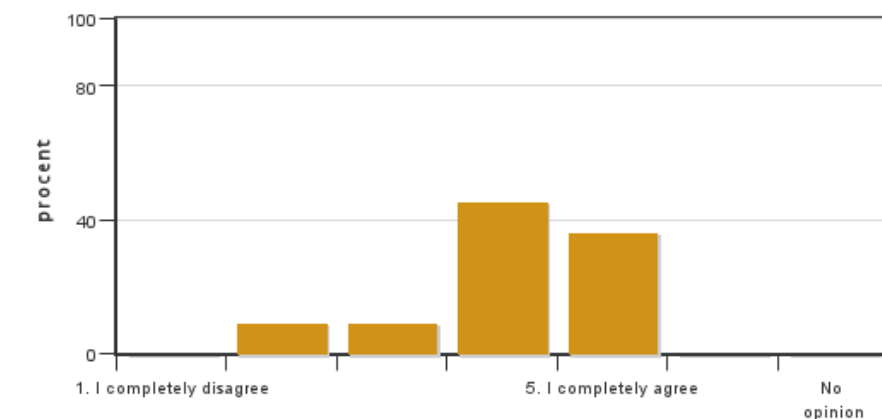

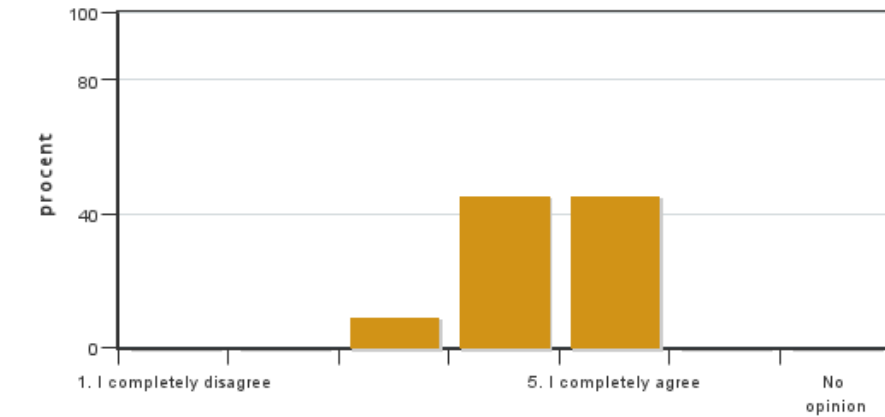

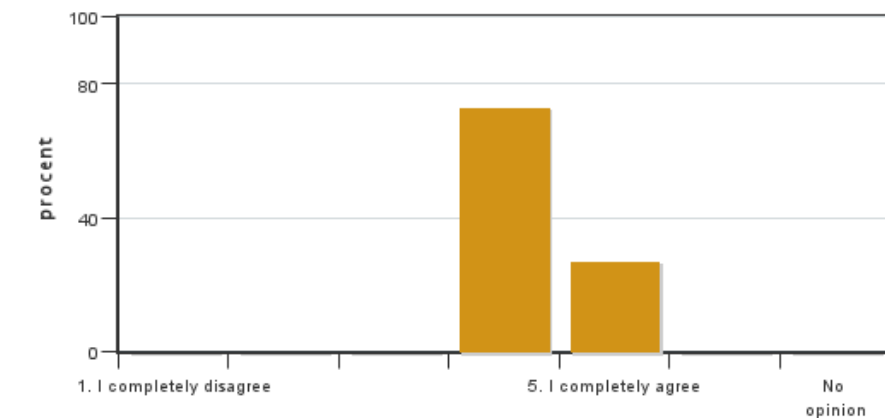

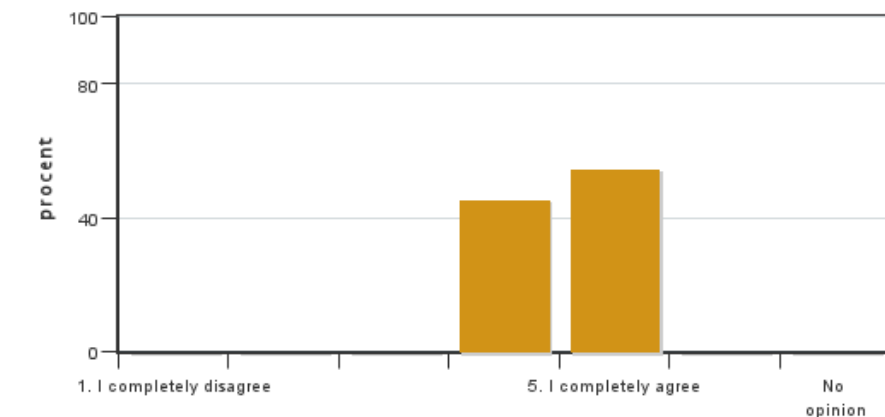

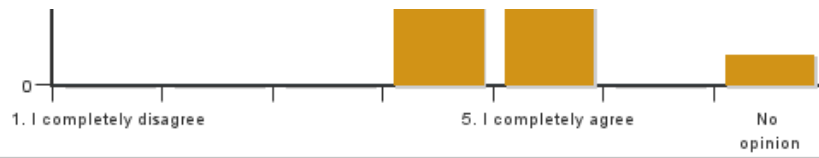

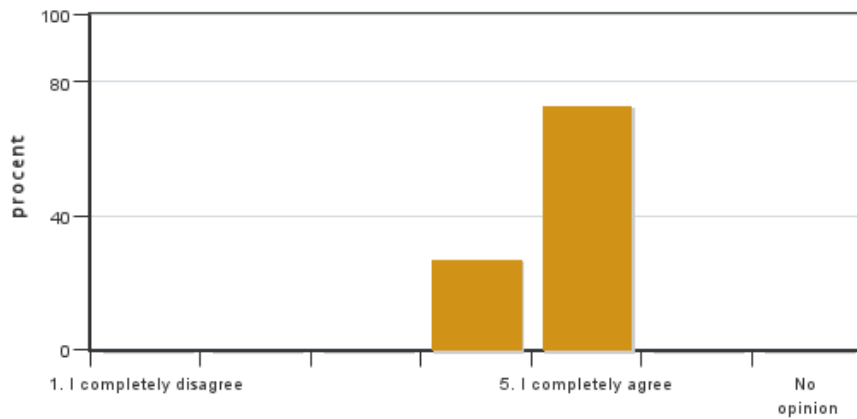

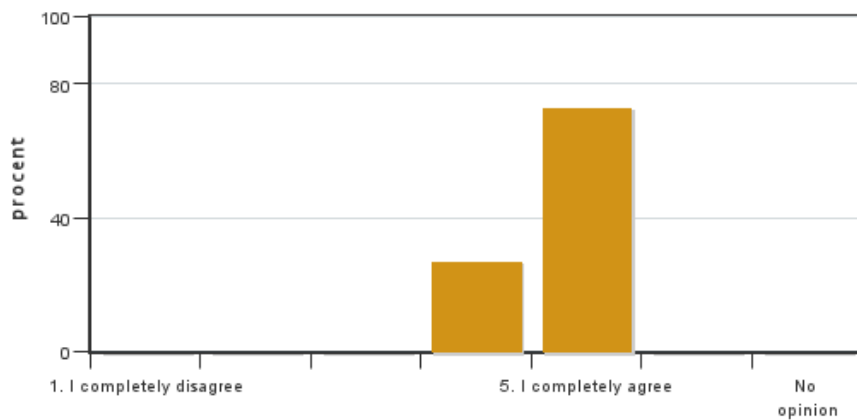

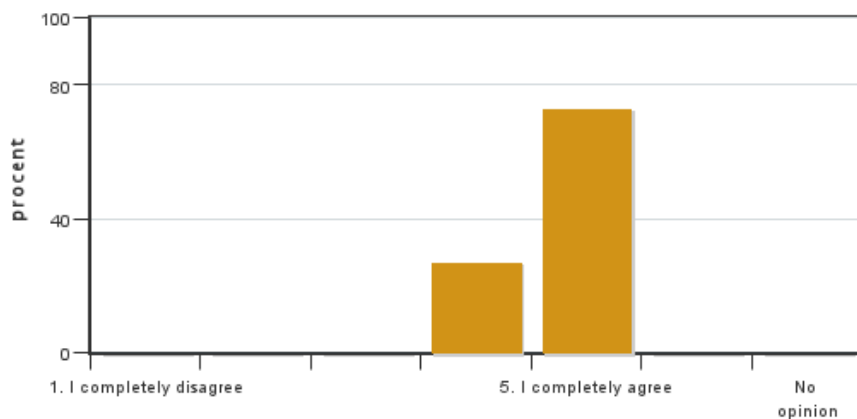

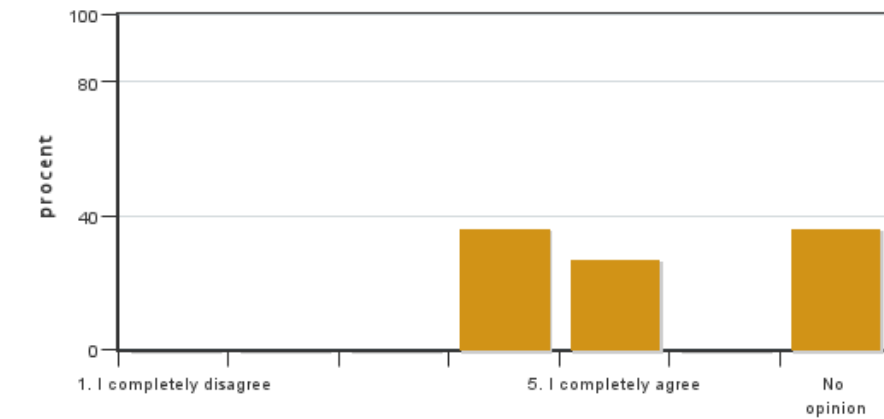

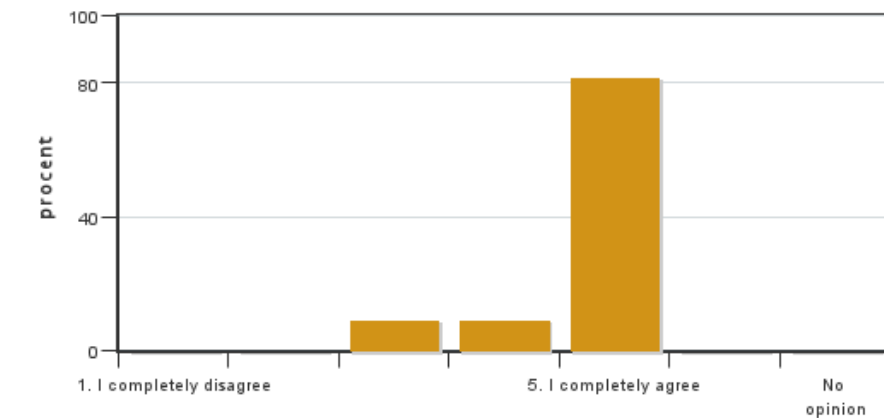

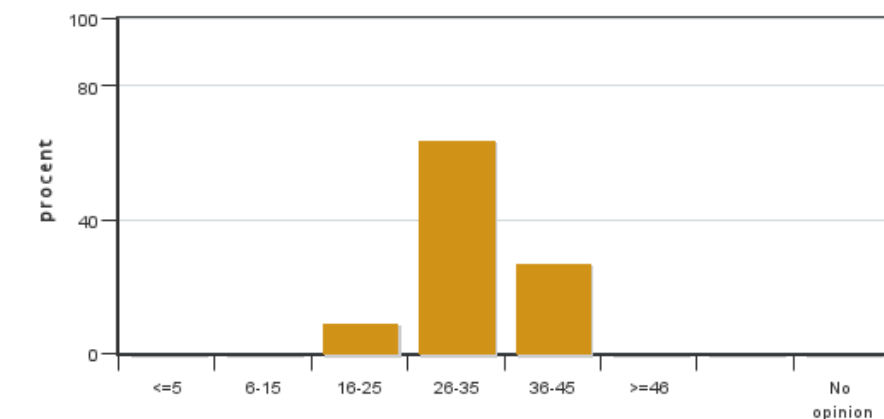

Course leaders comments

Course evaluation for Product Development and Innovation Systems in Horticulture (2023)

The overall evaluation of the course was good (4,4). Links to the learning objectives were (4,1) and the course information was easily accessible (4,3). The students perceived that the various course components supported their learning (4,5) and the social learning was good (4,7) as well as the physical learning environment (4,7). The examinations provided a good opportunity to demonstrate learnings (4,7) and students perceived the course to cover sustainable development aspects (4,7), international perspectives (4,7) and gender perspectives (4,4). We will try to continue to avoid on-line lectures even more next year. However, when appropriate (e.g. supervision) we will continue to have activities digitally.

The course book is appreciated, however, the link between the course book and teaching activities must be developed further.

Exercises were perceived as relevant, however adjustments will be made to the time allocated to the different parts.

Next year we will continue to work on the inter-disciplinary parts of the course.

Within the teacher team we will also continue to work on developing the instructions connected to included exercises, especially the product development project.
